1. Purpose

2. Legal basis

Your personal data will not be stored for longer than necessary, unless we have to keep your data for longer because of a statutory regulation.

4. Security

We handle your personal data carefully. To prevent unauthorised access, we have taken technical and organisational measures that ensure an appropriate level of security. In light of this, we have put in place security measures for our website, our IT systems and the physical areas where personal data is stored, whereby only authorised personnel can view your personal data.
